

RURAL MUNICIPALITY OF LUMSDEN No. 189

BYLAW NO. 2023-10

A BYLAW TO REGULATE THE SPEED OF VEHICLES ON CERTAIN PORTIONS OF ROAD.

The Council of the Rural Municipality of Lumsden No. 189, in the Province of Saskatchewan, enacts as follows:

1. Definitions:
 - (a) **“highway”** means a road, parkway, driveway, square or place designed and intended for or used by the general public for the passage of vehicles, but does not include any area, whether privately or publicly owned, that is primarily intended to be used for the parking of vehicles and the necessary passageways on that area; as defined in the Traffic Safety Act, Chapter T-18.1 of the Statutes of Saskatchewan, 2004.
 - (b) **“motor vehicle”** means a vehicle propelled or driven by any means other than by muscular power; as defined in the Traffic Safety Act, Chapter T-18.1 of the Statutes of Saskatchewan, 2004.
2. No person shall operate a motor vehicle at a speed greater than 60 km per hour on the Grid 734 highway, commonly referred to as “Old No. 11 Highway”, from the most easterly boundary limit of the Town of Lumsden to the intersection of Grid 734 and the road allowance located along the WNW 27-19-21-W2.
3. No person shall operate a motor vehicle that exceeds three (3) tonnes at a speed greater than 40 km per hour on Township Road 210 from Highway 54, two (2) miles West to Range Road 2223 and on Range Road 2223 two (2) miles North from Township Road 210 to Township Road 212 for a total of four (4) miles.
4. No person shall operate a motor vehicle at a speed greater than 60 km per hour on Township Road 194 adjacent to SW 29 19 21 W2; and no greater than 40 km per hour on the interior roadways within the Minerva Ridge subdivision (Apollo Drive, Hera Place, Eros Bay).
5. No person shall operate a motor vehicle at a speed greater than 40 km per hour on Township Road 190 from 50.56998 ° N, 104.84096 ° W (in a portion of the NW 33-18-21-W2) to 50.57098 ° N, 104.82793 ° W (in a portion of the NE 33-18-21-W2).
6. Signs indicating the maximum speed allowed shall be erected at the commencement of the speed zone area and signs shall be erected showing the end of the speed zone area.
7. The penalty for speeding shall be specified in *The Summary Offences Procedure Regulations, 1991*.
8. The following Bylaw is hereby repealed: 2021-02.
9. That this bylaw shall come into force and take effect on the final day of its passing.

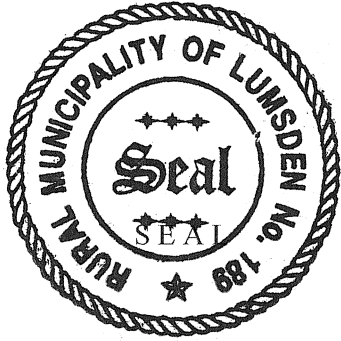
Readings
