**BYLAW NO. 2025-02**

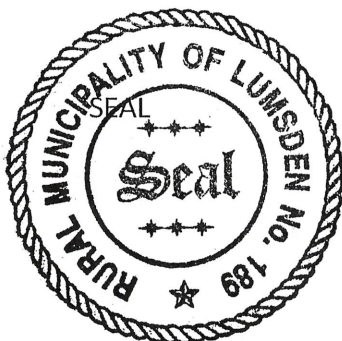
A bylaw to amend Bylaw No. 7-2012, known as the Zoning Bylaw of the Rural Municipality of Lumsden No. 189.

Pursuant to subsection 46(3) of *The Planning and Development Act, 2007* the RM of Lumsden No. 189 in the Province of Saskatchewan, by and with the advice and consent of the RM of Lumsden No. 189 Council, enacts to amend Bylaw No. 7-2012 as follows:

1. The Zoning District Map referred to in Section 5.2.1 is amended by rezoning Parcel A, Plan 96R08987, a ±5.06 hectares (12.5 acre) parcel of land, from the A – Agriculture District to the M - Industrial District as shown outlined in red on the attached map, which is attached hereto as Schedule "A" and forms part of this bylaw.
2. This Bylaw shall come into force and take effect when approved by the Minister of Government Relations.

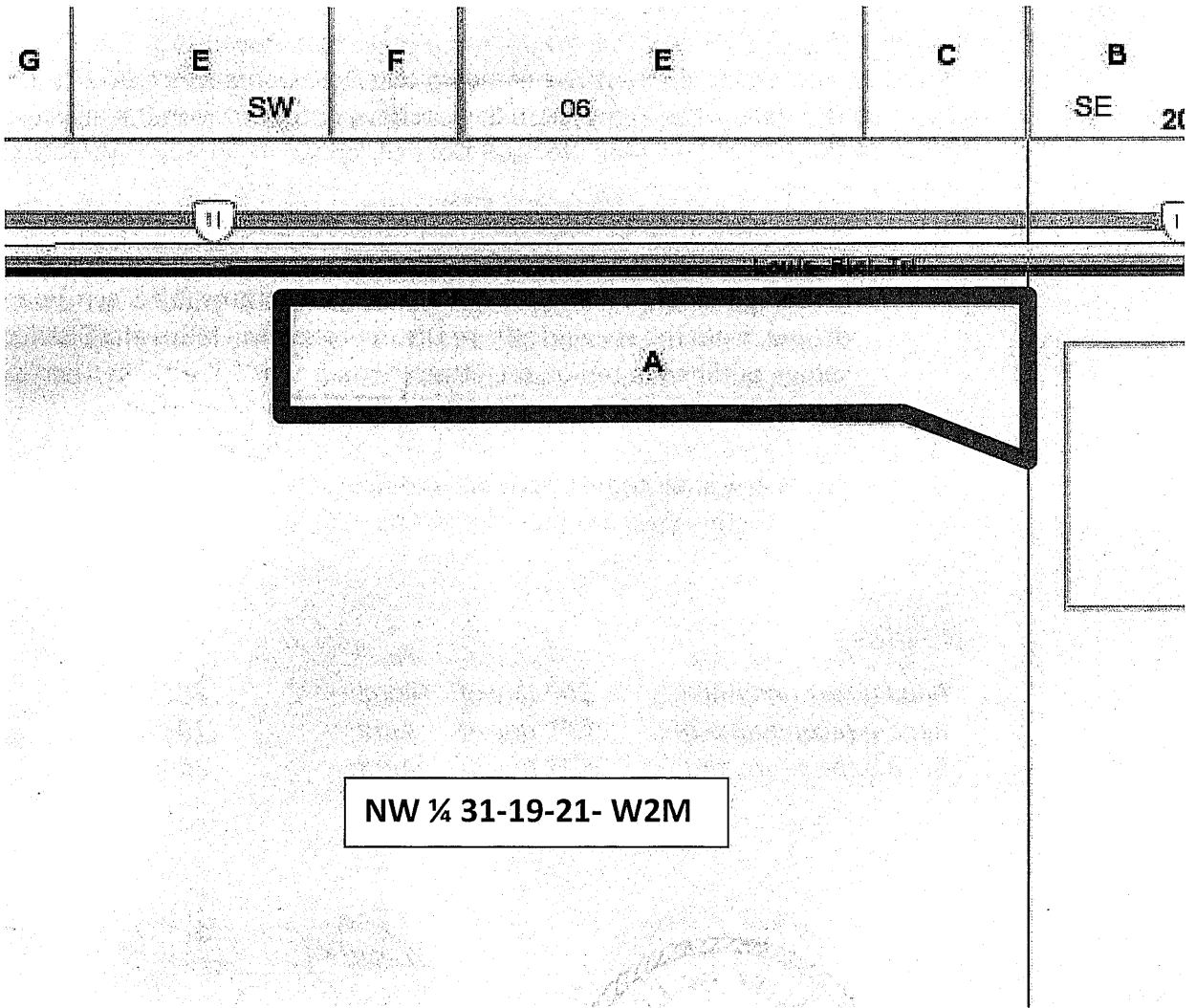
